3. In what ways do you feel prepared for this position? In what areas are you least prepared and how would you overcome/correct those areas? **(Buck)**
4. What do you see as a campus responsibility for environmental resource management? **(Hidalgo)**
5. What should be the burden on a complainant who make a title 9 complaint and what should have to be shown in order to change the status quo of a respondent. **(Abood)**
6. Please describe your approach to working across institutional silos to both accomplish goals and create a sense of shared vision and unity of purpose. Describe a time when you worked a create a win-win solution by collaborating with colleague institutions. **(Mathews)**
7. After social distancing is over what role do you think online will have in community colleges? How do you mitigate the effects on staff and on students? **(Proctor)**
8. What are the unique needs of students in dual enrollment? Are there any specific courses or services you would suggest that we add to our current dual enrollment program for high school students? **(Meyer)**
9. What experiences do you have that you feel help you relate to our student population? **(Vaive)**
10. How do you address the issues of intimidation and/or a lack of transparency and create an environment of inclusion? **(Buck)**

11. How do you define the success of a student at a community college? **(Hidalgo)**
12. How do you feel about students, staff and faculty using, possessing edibles (marijuana) on campus and in class? **(Abood)**
13. What responsibility, if any, do you feel community colleges have to teach soft skills. How do you balance teaching these with getting students quickly to their goals? **(Mathews)**
14. How do we engage students holistically in the non-linear career environment we are experiencing? **(Proctor)**
15. What core values do you bring to your profession? Give an example of how these core value are evidenced in your work. **(Meyer)**
16. Please share your experiences to engage and sustain community involvement with the community college. How do you engage the community to take ownership and have pride in their institution? **(Vaive)**
17. How would you feel about a student's right to exercise his or her 2nd amendment especially in the event the student may have a PPO out against an stalker? **(Abood)**
